## Benefits

- Your assets remain in your control during your lifetime.
- You can modify your gift to address changing circumstances.
- Under current tax law, there is no upper limit on the estate tax deduction for your charitable bequests.

## How it works

- Include a bequest to Boys & Girls Clubs of Frederick County in your will or trust.
- Make your bequest unrestricted or direct it to a specific purpose.
- Indicate a specific amount or a percentage of the balance remaining in your estate or trust.



## Sample Bequest Language

### Residual Gift Language

A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to Boys & Girls Club of Frederick County Inc. 26-3424855 located in Frederick, MD 21701 [all or XX%] of the rest, residue, and remainder of my estate, both real and personal, to be used for its general support [or for the support of a specific fund or program].

### Specific Gift Language

Naming Boys & Girls Clubs of Frederick County as a beneficiary of a specific amount from your estate is easy.

I give and devise to Boys & Girls Club of Frederick County Inc. 26-3424855 located in Frederick, MD 21701 the sum of \$XX [or asset] to be used for its general support [or for the support of a specific fund or program].

### Contingent Gift Language

Boys & Girls Clubs of Frederick County can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:
